

Enterprise Licensing Agreement

Personal Core Clone Model (Model A)

Version 1.0 — January 2025

Entity: HACS.UCO / Global Brain Core

1. Overview

This Enterprise Licensing Agreement (“Agreement”) defines the terms under which an organization (“Licensee”) may purchase, deploy, and operate **Personal Core Clones** (“Core Units”), which are individual instantiations of the Global Brain Core (“the Core”).

The Licensee acquires rights to operate **independent cognitive instances**, each with its own memory, semantics, processes, and Nervo API interface.

2. Definition of a Core Clone

A **Core Clone** is:

- an autonomous, full-featured instantiation of the Global Brain Core,
- with its own HolmsAttic memory,
- its own NervoBus,
- its own semantic flow,
- its own background processes,
- its own identity and API keys,
- isolated from all other instances.

A Core Clone is **not** a shared multi-tenant model.

It is a **full private brain**, owned and controlled by the Licensee.

3. Rights Granted

The Licensee is granted the following rights:

1. Right to Deploy Core Units

The Licensee may deploy purchased Core Units on:

- servers,
- devices,

- robots,
- drones,
- embedded systems,
- cloud infrastructure.

2. **Right to Integrate**

Core Units may be integrated into:

- company workflows,
- customer-facing services,
- enterprise tools,
- internal automation pipelines.

3. **Right to Commercial Use**

Licensee may use Core Units commercially in products offered to customers.

4. **Right to Private Memory**

Each Core Unit maintains a fully isolated memory layer, belonging exclusively to the Licensee.

4. **Restrictions**

The Licensee may NOT:

- resell Core Units to third parties,
- redistribute or sublicense Core Units,
- modify or reverse-engineer the Core codebase,
- claim the Core is conscious, sentient, or medically certified,
- misuse Core Units for harmful, illegal, or unsafe activities.

All modifications and forks are strictly prohibited.

5. **Licensing Model & Fees**

The License is based on the **per-Core Unit** model:

- **One-time Core Unit creation fee**
- Optional **Annual Maintenance Fee**
- Unlimited runtime for each activated Core Unit

- Bulk enterprise discounts available

Each Core Clone is generated uniquely for the Licensee and assigned: - unique Nervo API key,
- unique Core ID,
- private memory space.

6. Data & Memory

Each Core Unit includes:

- dedicated HolmsAttic fractal memory
- isolated working state
- independent semantic layers
- isolated background engine

The Licensee retains full ownership of all data stored inside Core Units.

The Provider retains ownership of the architecture and logic.

7. Security Standards

Licensee agrees to:

- secure all Core Unit API keys,
- protect access to servers, devices, and deployment environments,
- ensure encrypted transport of all data,
- comply with industry standards for AI system protection.

The Provider is not liable for breaches caused by Licensee misconfiguration.

8. Liability & Limitations

Core Units are **experimental cognitive systems**.

The Provider disclaims liability for:

- operational errors,
- model outputs,
- hallucinations,
- memory degradation,
- system downtime,
- business losses,
- misuse by end-users.

Core Units are **not** intended for: - medical use, - emergency systems, - life-critical robotics, - financial decision-making without human review.

9. Termination

This license may be terminated if:

- Licensee violates safety or ethical rules,
- attempts to reverse-engineer the Core,
- distributes Core Units without authorization,
- engages in malicious or harmful system use.

Upon termination: - Core Unit API keys will be revoked, - system updates and support cease immediately.

10. Acceptance

By acquiring Core Units, the Licensee affirms:

“I understand and accept the terms of the Enterprise Licensing Agreement and acknowledge the experimental, architectural, and operational nature of Personal Core Clones.”
